Recovery Residence Admission Criteria

Recovery Residence is a safe, clean, sober, residential environment that promotes individual recovery through positive peer group interactions among house members and staff. Housing is an affordable, alcohol and drug free and allows the residents to continue to develop their individual recovery plans and to become self-supporting.

Admission to a Recovery Residence is determined by several criteria; including a client meeting medical necessity, formal interview by the Recovery Residence House and client agreeing to all terms and conditions. The following are required for the admission to Recovery Residency:

- 1. Resident must meet medical necessity for ASAM Level of Care: 1 Outpatient Services, 2.1 Intensive Outpatient Services or Recovery Services.
- 2. Participating in Substance Use Treatment Services or Recovery Services through Marin County BHRS during their entire length of stay.
- 3. Meet, at a minimum, the following risk ratings of the ASAM Criteria:

Dimension 1: Substance Use, Acute Intoxication, Withdrawal Potential	0-1
Dimension 2: Biomedical Condition and Complications	0 – 2
Dimension 3: Emotional, Behavioral, or Cognitive Condition and Complications	0 – 2
Dimension 4: Readiness to Change	0 – 1
Dimension 5: Relapse, Continued Use, or Continued Problem Potential	0 – 2
Dimension 6 Recovery/Living Environment	2 – 4

- 4. Agree to submitting to a substance Drug Screening at any time during the residents stay.
- 5. Attend regular house meetings with house managers, and/or operators. These meetings may be in a group setting with other residents of the Recovery Residence.
- 6. Comply with all House rules, standards and procedures. House rules may include curfew, smoking, chores, payment of rent, and attendance at house meetings, and self-help meetings, and must include prohibition of any use of alcohol and or drugs
- 7. All prescription medications must be disclosed by the prospective resident and a 7- day minimum supply must be on hand prior to the resident moving into Recovery Residence. Clients must disclose any prescribed medications and understand and abide by Prescription Drug Policy.
 - a. Prospective residents CANNOT be denied services based on prescribed medications
- 8. Agree to all Residents terms and conditions outlined in <u>Marin County Sober Living Standards</u> and <u>Exhibit A Recovery Residence/SLE</u>

Lengths of Stay

Marin County BHRS projects that financial assistance for one 12 months, longer than 12 months will be authorized on a case-by-case basis, to eligible individuals may range from 100% assistance initially to decreasing amounts of financial assistance as individuals become more self-sufficient in the community (obtain job, etc.) Projected costs are up to \$1,240/month per individual, dependent upon the level of services provided at the Recovery Resident site.

The following is a standardized fee schedule for all individuals who are determined to need financial support, unless specific individual agreements are made with the County of Marin BHRS:

- Month 1: One-time \$300 Administration Fee
- Months 1-4: County pays 100%, no client co-pay (not to exceed \$1,240/month)
- Months 5-8: County pays 75%, client co-pay 25% (not to exceed \$930/month)
- Months 9-12: County pays 50%, client co-pay 50% (not to exceed \$620/month)
- Months 12+: County will authorize on a case-by-case basis
