## INTRODUCTION

The purpose of the Perinatal Directory (Directory) is to provide a current list of publicly funded substance use disorder (SUD) treatment programs for pregnant and parenting women (PPW) in California. Please note that some counties provide SUD treatment services within county departments including Health and Human Services, Alcohol and Other Drug Services, or Behavioral Health. For programs that are contracted and provide services with more than one county, those programs are only listed under the county where the program is physically located.

This Directory also includes a list of the service modalities and definitions, as offered by the county SUD treatment programs. Service modalities are listed after the address of each treatment program.

The Department of Health Care Services, Community Services Division ensures that programs comply with requirements set forth in the Substance Use Prevention, Treatment and Recovery Services Block Grant follow the requirements set forth in the 45 Code of Federal Regulations (CFR), Part 96, Subpart L. Pursuant to CFR §96.131(d)(1) by providing the Directory as a resource for referrals. *If a treatment facility does not have availability for a pregnant woman who seeks treatment, referrals must be provided to another treatment facility.<sup>i</sup> In the event that no other program is available, treatment programs must provide interim services.<sup>ii</sup>* When referring PPW to SUD treatment programs or interim services, please follow the Perinatal Practice Guidelines.

## TECHNICAL ASSISTANCE AND PROGRAM SUPPORT

The Department of Health Care Services, Community Services Division provides program support and technical assistance (TA) to counties and providers. # SERVICE MODALITIES

## Withdrawal Management

Withdrawal Management (WM), previously known as “detox,” or detoxification, is a service to assist a patient’s withdrawal. WM services may be provided at a residential facility, may vary in length, and are medically supervised.<sup>iii</sup>

## Narcotic Treatment Program

Narcotic Treatment Programs (NTPs), also referred to as Opioid Treatment Programs (OTP), deliver narcotic replacement therapy.<sup>iv</sup> They provide medication assistance to opioid users to aid in relief from symptoms of withdrawal from narcotics. Treatment is prescribed by a physician. Narcotic Replacement Therapy (NRT) is the most widely known and well researched treatment for opiate dependency. They are available to patients’ receiving treatment in a licensed NTP (NTP).<sup>v</sup>

## Outpatient Drug Free

Outpatient drug free (ODF) services are provided in an outpatient setting, such as a counseling center, clinic, or facility. Treatment may include medications, counseling, groups, support, and/or a 12-step approach. The length of treatment and the number of weekly hours depend on the assessment of the client, and the recommendation from the treatment team.<sup>vi</sup>

## Intensive Outpatient Treatment

Intensive Outpatient Treatment (IOT) programs are an organized service delivered by addiction professionals providing a structured treatment program that includes nine hours of treatment per week for adults, typically spread over three days.

## Residential

Recommendations for Residential is based on assessment of the person. Program length varies and depends on the design of the program, but length can range from 30 days up to 18 months. Some residential programs provide in-house WM, medical needs, classes, groups, counseling, and support for re-integration. Program design varies and may include transitioning the client from residential to transitional housing (TH) or another less-structured environment.

## **Transitional Housing**

Transitional Housing (TH) settings may be in a house or connected to a facility or campus. TH assists the participant with skills and resources to remain sober and to transition into permanent housing.<sup>vii</sup> In addition, THs are sober living environments shared with other participants and their children. Programs may offer daycare while the parent is in group counseling, individual counseling, and job searching. Programs vary in structure, requirements, and length. All the TH programs in this Directory allowed children with their mothers.

## **Recovery Bridge Housing**

Recovery Bridge Housing (RBH) is a short-term housing program, which usually spans 30 to 90 days. The structure is a sober living environment. This environment assists people transitioning in or out of treatment programs, including anyone waiting for permanent housing and perinatal patients who are pregnant to 60 days postpartum.<sup>viii</sup>

## **Medication Assisted Treatment**

Medication-assisted treatment (MAT) is the use of medications, in combination with counseling and behavioral therapies, to provide a “whole-patient” approach to the treatment of SUD. Medications used in MAT are approved by the Food and Drug Administration and MAT programs are clinically driven and tailored to meet each patient’s needs. MAT is primarily used for the treatment of addiction to opioids such as heroin and prescription pain relievers that contain opiates.<sup>ix</sup>
